1. (C) REDENT INTELLIGENCE INDICATES THAT CERTAIN BUDDISTS ELEMENTS WILL CONDUCT A DEMONSTRATION IN QUANG NGAI PROVINCE DURING THE PERIOD 3-4 JAN 1971. IT IS ANTICIPATED THAT THE ACTIVITIES WILL CENTER IN THE VILLAGES AND POPULATION CENTERS ALONG QL-1.

2. (C) IN AN EFFORT TO AVOID ANY US/VN CONFRONTATIONS AND IN AN EFFORT TO PRECLUDE VEHICLE ACCIDENTS ON QL-1, VEHICLE TRAFFIC WILL BE MINIMIZED REPERT MINIMIZED. ADDITIONALLY, ALL OFF POST VEHICLE DISPATCHES AND VISITS TO DUC PHO AND QUANG NGAI WILL BE HELD TO AND ABSOLUTE MINIMUM.

SUBJ: CHANGES TO CLAIMS EVALUATION STANDARDS

1. THE CHIEF, U.S. ARMY CLAIMS SERVICE, OFFICE OF THE JUDGE ADVOCATE GENERAL, FORT HOLABIRD, MARYLAND, RECENTLY APPROVED A CHANGE IN CLAIMS PROCEDURES EFFECTIVE ONLY WITHIN VIETNAM WHICH PERMITS PAYMENT FOR LOSS OF GOODS BY LARCENY FROM THE PERSON IF THE NEGLIGENCE OF THE OWNER DID NOT CONTRIBUTE TO THE LOSS, CONTEMPLATED SITUATIONS INCLUDE THEFT OF WATCHES, CAMERAS AND SIMILAR ITEMS FROM THE PERSON OF MEMBERS OF THE SERVICE AND CIVILIAN EMPLOYEES OF THE DEPARTMENT OF DEFENSE WHILE THE VICTIM IS EITHER WALKING OR RIDING IN A VEHICLE, IN THE MOST COMMON OF THESE SITUATIONS THE THIEF IS RIDING ON A MOTORCYCLE AND SIMPLY SPEEDS AWAY, UNDER THE NEWLY APPROVED PROCEDURES THE VICTIMS MAY RECEIVE PAYMENT FOR HIS LOSSES UPON PRESENTATION OF HIS CLAIM AND PROOF OF LOSS WITHOUT REGARD TO WHETHER HE WAS ON DUTY OR OFF DUTY AT THE TIME, HE MUST NOT, HOWEVER, BE AWOL OR IN AN OFF-LIMITS AREA.

2. THE INDIVIDUAL MUST BE ABLE TO SUBSTANTIATE HIS CLAIM OF LOSS, IF

PAGE TWO UNCLASSIFIED

POSSIBLE, HE SHOULD SUBMIT WITH HIS CLAIM A STATEMENT BY ANOTHER WITNESS THAT HE POSSESSED THE ITEM AND THE CIRCUMSTANCES UNDER WHICH IT WAS STOLEN, HE SHOULD ALSO REPORT THE THEFT IMMEDIATELY TO THE NEAREST MILITARY POLICE OFFICE AND SUBMIT A COPY OF THE MILITARY POLICE REPORT WITH HIS CLAIM.

13. ALL MEMBERS OF YOUR COMMAND WILL BE INFORMED OF THE ABOVE POLICY AND

ADVISED THERE IS A LAWFUL WAY TO OBTAIN RE-IMBURSEMENT AND THAT EVEN ACTS OF WANTON THIEVERY DO NOT CONSTITUTE JUSTIFICATION FOR SHOOTING THE THIEF OR SIMILAR VIOLENT ACTS.
